

## SUMMARY ANNUAL REPORT FOR NECA LOCAL 145 IBEW WELFARE FUND

This is a summary of the annual report for NECA Local No. 145 IBEW Welfare Plan, EIN 42-6062181 Plan number 501, for the period October 1, 2005 through September 30, 2006. The annual report has been filed with the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### Insurance Information

The Plan has a contract with an insurance carrier to pay specific and/or aggregate reinsurance claims incurred under the terms of the Plan. Total premiums paid during the plan year were \$391,530.

### Basic Financial Statement

Plan assets, after subtracting liabilities totaled (\$33,003,196) as of September 30, 2006, compared to (\$38,364,659) as of October 1, 2005. During the year the Plan experienced a change in its net assets of \$5,361,463. This change includes unrealized appreciation or depreciation in the value of Plan assets; that is the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$13,431,686 which included employer contributions of \$7,725,657, employee contributions of \$1,004,507 a realized gain/(loss) of \$509,674 from the sale of assets, and \$884,166 in earnings from investments. The plan has a Post-Retirement Benefit obligation of \$45,100,286.

Total Plan expenses were \$8,070,223. These included \$7,694,041 in benefits paid to participants and beneficiaries, \$376,182 in administrative expenses and \$0 in other expenses.
